

CITY OF PRINCE ALBERT BYLAW NO. 33 of 2008

*A Bylaw of the City of Prince Albert to amend
the Traffic Bylaw,
Bylaw No.16 of 2005.*

WHEREAS, it is deemed expedient to amend Bylaw No. 16 of 2005 for the purpose of amending the Schedule "55 (b)" with respect to School Zones and amending Schedule "43" with respect to the Heavy Vehicle Route.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF PRINCE ALBERT IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. That Schedule "55(b)" appended to Bylaw No. 16 of 2005 be deleted and Schedule "55(b)" appended hereto be substituted therefore, and all references to Schedule "55(b)" in Bylaw No. 16 of 2005 shall refer to the attached.
2. That Schedule "43" appended to Bylaw No. 16 of 2005 be deleted and Schedule "43" appended hereto be substituted therefore, and all references to Schedule "43" in Bylaw No. 16 of 2005 shall refer to the attached.
3. This Bylaw shall come into force and take effect on, from and after the

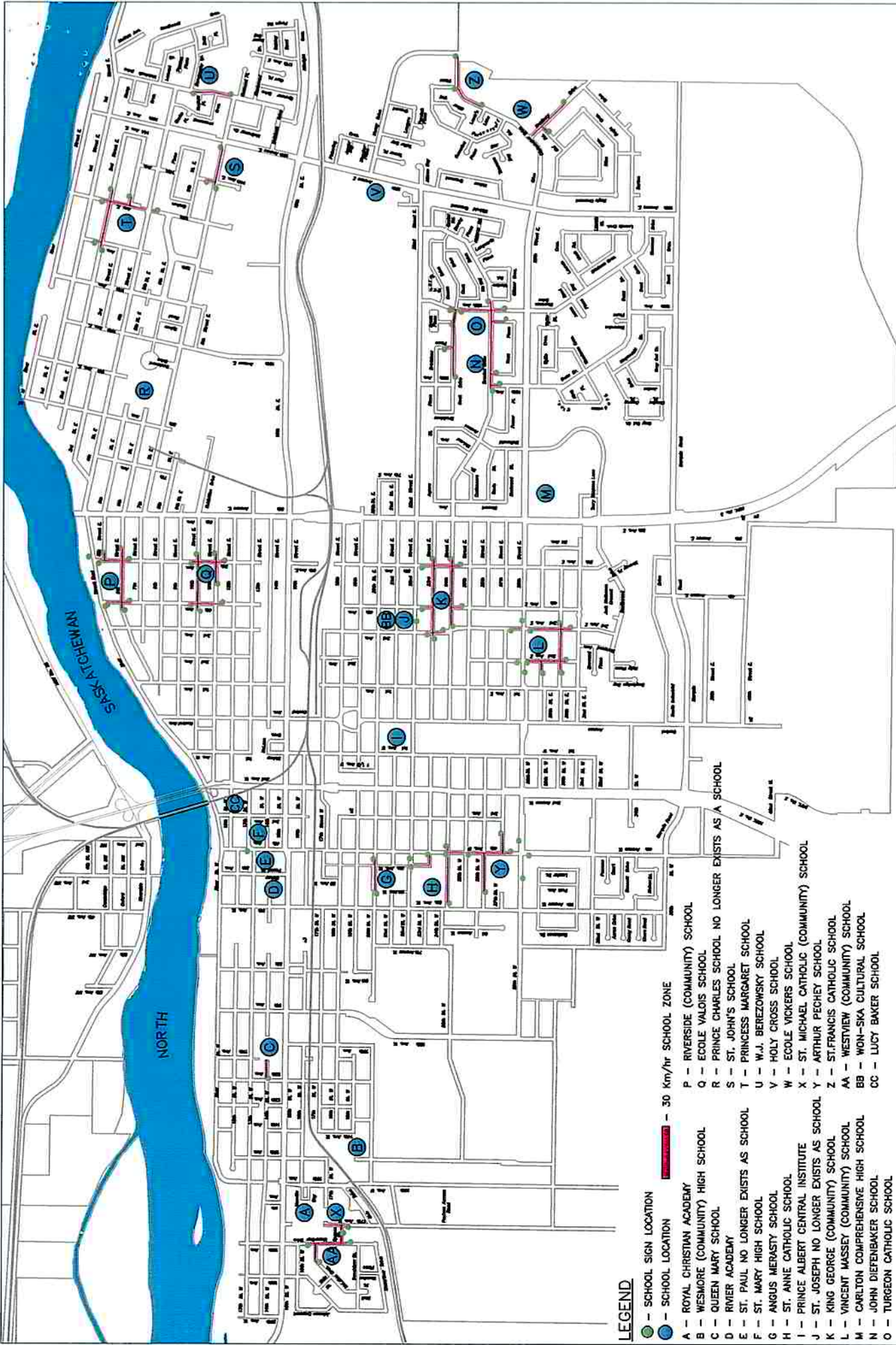

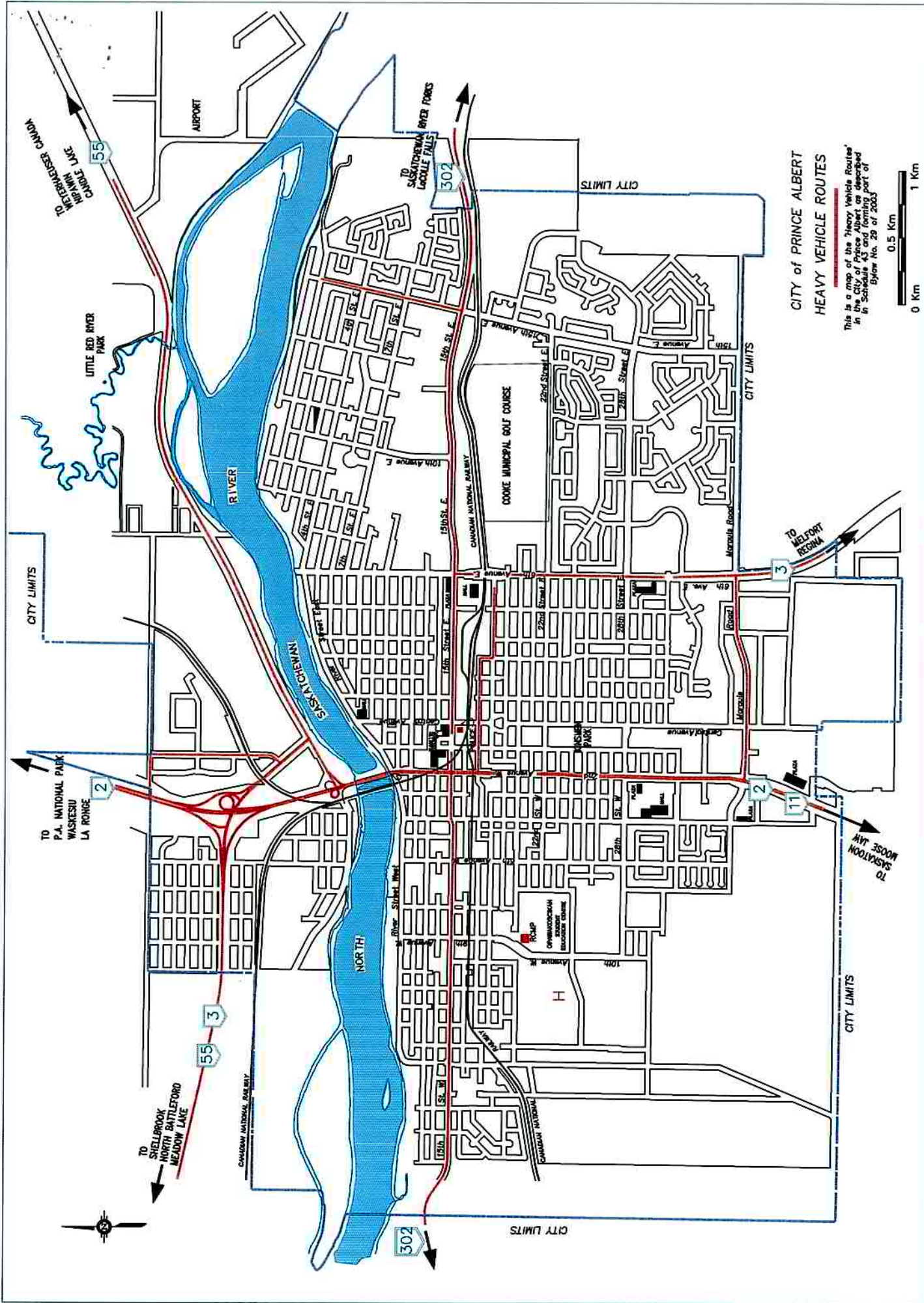
