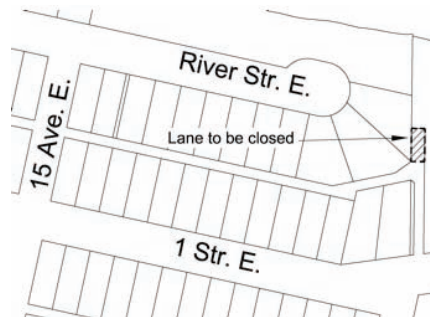

ROAD CLOSURE NOTICE

PROPOSED ROAD CLOSURE BYLAW NO. 11 of 2010

Prince Albert City Council is considering a lane closure pursuant to Sections 13 and 102 of *The Cities Act, 2002* and City of Prince Albert Public Notice Policy Bylaw 5 of 2003 and hereby gives notice to consider **Bylaw 11 of 2010** to authorize the road closure outlined below:

Reason for the Amendment – This lane once closed will facilitate a land exchange to accommodate an extension of the Rotary Trail to the River Park.



City Council, at its meeting to be held on Monday March 8th at 7:00 p.m., will consider all submissions either orally or written respecting the above application. In accordance with City Council's Procedure Bylaw No. 10 of 2005, all written submissions must be signed and provided to the City Clerk. If you would like your written submission reviewed by members of Council prior to the meeting, you are required to provide your submission by 4:45 p.m. on Tuesday, March 2nd, 2010.
