- 0173. Moved by: Councillor T. Zurakowski

That Item No. AC-02 – Airport Snowmobile at a cost of \$9,000 to be funded from the Airport Improvement Fund be removed from the 2019 Airport Capital Budget.

That Item No. AC-06 – New Terminal – Conceptual Design at a cost of \$100,000 to be funded from the Passenger Facility Fee Reserve be removed from the 2019 Airport Capital Budget.

 - a. Operating revenues of \$978,610;
 - b. Operating expenses of \$889,470;
 - c. Capital and Interfund Transactions of \$299,370; and,
 - d. A surplus of \$388,510 to fund Capital Projects and Reserve Transfers;
- 2. That the 2019 Airport Fund Capital expenditures of \$703,000, as identified as AC-01, AC-03 AC-05, AC-07 and AC-08 in Appendix B to RPT 18-583, be approved;
- That the 2020 2023 Airport Fund Capital expenditures, as attached in Appendix C to RPT 18-583, be approved in principle, subject to final approval of the annual Budget for each year; and,

4. That The City of Prince Albert 2019 Airport Fund Operating and Capital Budgets, as amended, along with the Resolutions of the Budget Committee, and a final covering report from the Director of Financial Services, be forwarded to City Council for final approval.

That Item No. LC-01 – West Hill Trunk – Sewer Main Stage #1 - 10th Avenue West to 2nd Avenue West Construction at an estimated cost of \$4,000,000 to be funded through the Development Levies Reserve be removed until a Funding Program comes forward that can be utilized.

- 2. That the 2019 Land Fund Capital expenditures of \$930,000 and Loan Principal Payments of \$183,600, as identified as LC-02 to LC-04 in Appendix B to RPT 18-579, and the Marquis Road West Extension, identified as follows, for an overall budget of \$1,113,600 funded by Reserves and the Land Development Fund, be approved:
 - An approximate cost of \$450,000 for Land Procurement to be funded from the Future Land Purchases Reserve; and,
 - An approximate cost of \$200,000 for Engineering Design and Tender to be funded from the Development Levies Reserve.
- 3. That the 2020 2023 Land Fund Capital expenditures, as attached in Appendix C to RPT 18-579, be approved in principle, subject to final approval of the annual Budget of each year; and,
- 4. That The City of Prince Albert 2019 Land Fund Operating and Capital Budgets, as amended, along with the Resolutions of the Budget Committee, and a final covering report from the Director of Financial Services, be forwarded to City Council for final approval.
