## - APPLICATION FORM FOR ONE (1) FREE PAINT KIT-

Property owners are eligible to apply to receive **one** (1) FREE Paint Kit per application and/or incident for graffiti removal on their own personal property.

**NOTE:** Paint Kits can NOT be used to paint over graffiti on other private, rented or public property (such as a neighbors fence, vacant garage in rear lane, neighborhood community centre, SaskPower electrical panel box, Canada Post Mail boxes, city owned facilities, community clubs, etc.). The Program does **not** cover other means of graffiti removal and is **not** retroactive. If you are a renter of the home, you may apply for the Paint Kit but you are responsible as the applicant for obtaining permission from the property owner to undertake the work.

1. COMPLETE THIS APPLICATION FORM. PLEASE BE PREPARED TO PROVIDE PROOF OF ADDRESS FOR THE LOCATION BEING APPLIED FOR (EX: TAX NOTICE, DRIVER'S LICENSE).
2. DELIVER APPLICATION FORM TO 3<sup>rd</sup> FLOOR COMMUNITY SERVICES DEPARTMENT, CITY HALL, 1084 CENTRAL AVENUE, 306-953-4800.
3. UPON RECEIPT OF THE COMPLETED APPLICATION FORM, THE ASSISTANT PARKS MANAGER WILL CONFIRM GRAFFITI LOCATION AND APPROVE THE APPLICATION. HE WILL THEN DELIVER A COPY OF THE APPROVED APPLICATION TO THE PROPERTY OWNER.
4. ONCE A COPY OF THE APPROVED APPLICATION IS RECEIVED, THE OWNER WILL BE ELIGIBLE TO VISIT THE APPROVED DISTRIBUTOR TO RECEIVE THEIR FREE PAINT KIT WHICH INCLUDES:
  - 1 quart/gallon Latex (tinted to the color of your choice)
  - 1 roller/brush
  - 1 paint tray
  - 1 pair of plastic gloves
5. PROGRAM IS AVAILABLE FOR AS LONG AS WEATHER PERMITS. APPLICATIONS RECEIVED WHEN TEMPERATURES ARE LESS THAN **0 DEGREES CELCIUS** WILL NOT BE CONSIDERED.
