## 2025 Watermain Replacement – 12<sup>th</sup> Street West (4-5 Avenue)

The City of Prince Albert Public Works Department would like to advise residents of the upcoming underground utility work on 4<sup>th</sup> Avenue West between 13<sup>th</sup> Street and River Street, as well as 12<sup>th</sup> Street West between 4<sup>th</sup> and 5<sup>th</sup> Avenue. The work includes tying in the newly relined watermain to existing infrastructure along 4<sup>th</sup> Avenue West (locations highlighted in orange) and the conventional excavation and replacement of 136 meters (Highlighted in Red) of 150mm diameter Cast Iron Watermain (1911) with a new PVC main. After the watermain replacement, asphalt milling, paving and select concrete repairs will take place. Residents can expect an additional notice to be delivered at this time for more information.


- 1. **Project timeline: August 11<sup>th</sup> to September 12<sup>th</sup>**, weather permitting.
- Impacted Areas: Watermain excavation and replacement will take place along the pipe segment highlighted in Red. During construction all properties highlighted in Blue will receive overland water but will remain on a Drinking Water Advisory. All properties highlighted in Green may experience temporary water service disruptions of no longer than 8 hours during watermain tie ins on 4<sup>th</sup> Avenue West.
- 3. **Traffic & Access**: 12<sup>th</sup> Street West (4-5 Ave) will be an open excavation for the duration of this project. This block will be closed for the safety of all residents. Rear lanes will be required to access your property. 4th Avenue West will be closed at times to facilitate watermain tie ins, vehicle access will remain available on 3<sup>rd</sup> Avenue and 5<sup>th</sup> Avenue at all times.
- 4. **Garbage and Recycling Pick-up** will continue as scheduled.
- 5. **Landscaping and Trees**: 6 trees were removed from the north side of 12<sup>th</sup> Street West between 4<sup>th</sup> and 5<sup>th</sup> Avenue to facilitate the conventional excavation and replacement of the existing 114-year-old cast iron watermain. The Forestry Division is in the process of preparing a replanting strategy for the north side of the block.
