#### **TOPIC & PURPOSE:**

This report reviews the total statistics related to crime and calls. This public report is to keep our community and the Prince Albert Board of Police Commissioners, informed on statistics for January 2022.

#### **BACKGROUND:**


Monthly statistics related to crime and calls are captured, reviewed, and released to the Board and public. The information in this report is measured and compared to previous years and is provided to identify anomalies or trends. This information can be used to determine community and organizational needs, and support decisions on resource deployment. Statistics are regularly updated based on outcomes of investigations; it is not uncommon to see statistics in these reports change within the current year or previous years.

#### **Total Calls**

The **total** calls for January 2022 (which is also YTD for the remainder of report) was 3,602. This is a 1.8% increase from the previous year.

The **proactive calls** or "neighbourhood strengthening" efforts in January 2022 was 206. This is an 65.9% decrease over the previous year.


The **calls for service** received in January 2022 was 3,371. That is an increase of 16.6% over the previous year. Eviction calls increased by 37.8%, missing persons increased by 90.5% and motor vehicle collisions increased by 102.3%.

#### **Victims of Violent Crime**


In 2022, there were 81 victims of violent crime. This is a 1.2% decrease from the previous year. That represents one (1) less victim than January of the previous year. The five-year January average of victims of violent crime is 91.

#### **Homicides**

In 2022, there was one (1) homicide victim, which is the same as in January 2021. The 2022 homicide is still under investigation.

#### **Victims of Sexual Violations**

In January 2022, there were four (4) victims of sexual violations. This is a 77.8% decrease over the previous year when there were 18 victims. All four (4) instances were reported as sexual assaults and one (1) file currently has charges, while the others remain under investigation. The five-year average for victims of sexual violations for January is 11.




**Appendix 4:** five-year trend sexual violation victims January.


#### **Victims of Assault**

In January 2022, there were 51 victims of assault, which is a 6.3% increase from 2021 and lower than the five-year average of 59.

The majority of victims were adult men at 51.1%, adult women were 46.8% and juvenile males made up the remainder at 2.1%



**Appendix 5:** five-year total victims of assault for the month of January.




Appendix 6: top three (3) assault types and the corresponding number of charges for January 2022.


#### **Robberies**

There were 12 victims of robbery in January 2022, which is a 200% increase from January 2021 when there were four (4) victims.

In 11 of the 12 instances, those involved were not known to each other. Five (5) instances occurred in "open-air/outside," two (2) involved a business, and two (2) were targeted robberies. One (1) instance had three (3) victims, where the rest had one (1). Firearms were brandished in five (5) instances which is also reported in firearms violations. Bear spray was brandished or used in two (2) robberies, and two (2) involved physical force or intimidation.




Appendix 7: five-year trend of robberies January 2022.




**Appendix 8**: heat map of robberies January 2022.

## **Property Crime**


In January 2022, there were 231 reports of property crime. That represents a 17.7% increase from January of the previous year, when there were 196.



**Appendix 9:** the five-year trend of property crime for January.




**Appendix 10:** January 2022 top five property crimes, compared to 2021.

#### **Arsons**


In January 2022, there were two (2) arsons, both were residences and are still under investigation.



Appendix 12: five-year trend of arsons for January.


#### **Break and Enters**

The five-year January average for break and enters is separated into types; residential, outbuilding, business and break and enter to steal firearms. In January 2022 there were 32 break and enters. This is the second-lowest number of break and enters in the last five (5) years.

In the month of January there were 13 break and enters to businesses, which is the highest number in the last five years. In 11 instances, entry was gained through glass that was broken. Four (4) were in the Cornerstone area and two (2) were auto show rooms. In four (4) of the instances charges have been laid.




Appendix 14: heat map of all break and enters January 2022.



#### **Theft of Motor Vehicle**

There were 43 vehicle thefts in January 2022, a 72% increase when compared to 25 instances the year prior. Charges of either theft or possession of stolen vehicle have been laid in seven (7) of the instances and 24 vehicles have been recovered. The others remain under investigation. In 12 instances, keys were left in the vehicle. In 29 instances, the doors were left unlocked. In 16 instances, the vehicles were warming up.



Appendix 15: keys left in vehicle January 2022.




Appendix 16: heat map of vehicle thefts January 2022.



#### **Firearms Seizures**

There were six (6) firearm seizures in January 2022. This is a decrease over the five-year average of nine (9). Three (3) of those were sawed off shot guns, while the remaining three (3) were a rifle, a restricted weapon and other firearm.




**Appendix 17:** five-year January trend of seized firearms and charges.



Appendix 18: how the firearms were seized in January 2022.


In January 2022, there were five (5) incidents where firearms were brandished or discharged. This is lower than January 2021 when there were eight (8).

#### **Controlled Drugs and Substances**


In January 2022, there were three (3) drug trafficking charges with zero possession charges. One (1) of those instances was the result of a search warrant. There were 177.4 grams of methamphetamine and 22.3 grams of crack cocaine seized. The five-year January average for drug charges is four (4).

#### **Arrests**

There were 343 total arrests in the month of January 2022. This represents 96 fewer arrests than January 2021 when 439 occurred. Top "other" reasons for arrest are for outstanding warrants and new charges.

#### **Tickets**

In January 2022 there were 324 ticket violations which is 44.1% decrease from January of the previous year. Combined Traffic Services Saskatchewan (CTSS) issued 61.1% of those tickets written. The top three violations were speeding, intoxication in public and unregistered motor vehicles.


