1 POLICY

- 1.01 A route change will be considered for the following reasons
- 1.01.1 Citizen Inquiry
- 1.01.2 Bus Driver Inquiry
- 1.01.3 Councillor Inquiry
- 1.01.4 Identified as an inefficiency within the system
- 1.01.5 Low ridership at stop
- 1.01.6 Required with overall route changes
- 1.01.7 Safety concerns for driver or transit patron
- 1.01.8 Increase in ridership can be realized with route change
- 1.02 Transit Routes will not be changed for the following reasons
- 1.02.1 A decrease in ridership will occur with change
- 1.02.2 A change will increase safety hazards for transit patrons or transit drivers
- 1.02.3 A change will decrease route efficiency
- 1.02.4 A change will decrease disabled accessibility of the route.
- 1.03 The Public Works Department will take a request for a change into consideration and before a change is made
- 1.04 Large Scale changes will be advertised through local media and on the Transit routes.
- 1.04.1 The Public will be given a chance to comment on the proposed changes at a public meeting before the change will occur.
- 1.04.2 Those unable to attend the public meeting will be able to provide their comments to administration in a letter within one week of the Public meeting.

- 1.04.7 Changes will occur and new maps will be made available on the bus
- 1.04.8 Drivers or Transit Staff will aid transit riders navigate the new transit system
- 1.05 Small Scale Transit changes will be advertised within the immediate area of the change
- 1.05.1 The Public will be given a chance to comment on the proposed change during the initial advertising period
- 1.05.2 The Public Works Department will advertise their intention to change the route, at the bus stop to be changed and on the bus route that is affected.

- 7.01 Small Scale Changes Procedure

- 7.01.2 Similar notices will be sent to health facilities, businesses, senior's homes, and multifamily units within 200m of the bus stop to be changed.
- 7.01.3 Concerns will be discussed and evaluated by the Cities Public Works Department and a decision will be made to either keep the bus stop in the same spot or move the stop.
- 7.01.4 Temporary signage will be placed one week in advance of moving a bus stop to let those using the stop and the bus be aware of the change that will occur.
