## Call for Indigenous Artists – Transit Shelter Art Designs

## 1 Background

The Parks, Recreation & Culture Department working with the Community Development Department have created a Transit Shelter Art project.

- Prince Albert has one of the highest Indigenous (First Nations, Metis and Inuit) population ratios in any Canadian City at 46% (2021 Census).
- This is an opportunity for our Indigenous population to see themselves in our city and to help with reconciliation in our community for a better future.
- This initiative links to the City's Municipal Cultural Action Plan, specifically Cultural Goal #5: Promote and communicate cross cultural understanding and learnings across nations, communities, newcomers and individuals. It also connects to the Public Art Plan goals and beautification of our city.
- There is a call to action from the Truth and Reconciliation commission for a strategy to recognize Indigenous history.
- The transit shelters have been the target of vandalism. Adding art to the shelters will provide a more welcoming environment and deter vandalism.

## 2 Objective(s)

The City of Prince Albert is seeking Indigenous Artists to create local designs for transit shelters in Prince Albert. The designs will depict Indiegnous cultures and foster community pride.

Our transit system is an important service in our city. Public art in and around transit routes can have a positive impact on the transit users and community. This project aims to:

- Engage local Indigenous artists;
- Celebrate our City's Indigenous people and culture, and contributes to reconciliation for our city;
- Provide a transit experience that is bright, welcoming and meaningful;
- Build and celebrate our City's identity through art, culture, and history;
- Promotes positivity and pride in our City, also known as Kistapinanihk, the great meeting place.

## 3 Eligibility

This call is open to Indigenous Artists in Saskatchewan with preference to those residing in Prince Albert or surrounding communities. We encourage submissions from artists that are typically underrepresented including LGBTQIA2S+ identifying individuals, deaf persons, and persons with disabailities. We also encourage submissions from youth. Closing Date: Wednesday, September 30<sup>th</sup>, 2025. Anticipated Approval: Tuesday, October 7<sup>th</sup>, 2025.

The City of Prince Albert reserves the right to accept or reject in whole or in part any or all submissions.

## 6 Requirements | Scope of Work

• Keeping the objectives (section 2) and intended benefits to our city in mind, in 2025, three designs will be chosen for the back side of three transit shelters (2 metal and 1 vinyl wrap). The Indigneous Arists will provide the designs in a digital renedering(s). Chosen designs will be placed on the back side of Transit Shelter Stations as desribed below. Chosen artists will be compensated \$1000 for their design. Other designs may be selected and filed for potential future use. Each artist can submit up to 6 designs. We expect the shelter backs to last 5-10 years. The Transit Shelter backs are eight feet wide by seven feet high. The bottom 6 inches may have the City of Prince Albert logo added.

The locations of the three designs to be chosen are:

#### Metal:

- Carlton High School
- 2<sup>nd</sup> Avenue West and 34<sup>th</sup> Street West

#### Vinyl Wrap (for glass):

• Sask Polytech (15<sup>th</sup> Street East)

#### <u>Technical Requirements/Specifications:</u>

- All artwork must be original to the artist and created for the purpose of this call.
- Final artwork design should contain appropriate levels of details and scale for viewing.
- Artwork should be provided as a digital rendering (jpeg format).
- The designs should be relatively simple (see examples attached).
- The design must all be connected. There cannot be any floating elements of the banner design as it will be cut into aluminum (3/16 inch).
- The designs will not include text, political or religious figures, and/or logos.
- The metal designs must have no more than 30% negative space. Please recommned one colour for powder coating of the metal.
- The vinyl wrap (for shelters with glass backs) designs must have no more than 50% art space and while they can have multiple colours, they must be transparent.
- The design must note the location that it is suggested for.

#### **Potential Future Phases**

This project has the potential for expansion and more designs chosen for Transit Shelters and Stations in future phases.

## **7 Submission Requirements**

A completed application form must include the support material listed below. Support material must be in a recognized DOC, DOCX, or PDF file format. Please write your name and contact information on the file.

- 1. **AUTHORIZATION/SUBMISSION FORM:** Complete, including a signature, the authorization form included in this document.
- 2. **EXPRESSION OF INTEREST:** 1 page maximum. Please provide a concise synopsis of your interest in the project and knowledge about the subject.
- 3. **RESUME / CURRICULUM VITAE:** Three (3) page maximum. Detail your experience as an artist, prior design or public art experience, and/or other relevant information. Include your name, mailing address, telephone number, and email address. If multiple artists are involved, include each artist's resume and indicate the artist team lead.

#### 4. VISUAL DOCUMENTATION

• **Images**: A maximum of five (5) digital image files of previous designs or artworks which best illustrate a body of artwork related to the project.

- 1. The Call for Indigenous Artists submission must be signed in the space provided on the *Authorization Form* with the signature of a signing officer.
- 2. The City of Prince Albert reserves the right to change or cancel the Call for Indigenous Artists without notice.
- Should a dispute arise from the Terms and Conditions of this Call for Indigenous Artists
  regarding meaning, intent or ambiguity, the decision of the City of Prince Albert shall
  be final.
- 4. Any submission is not necessarily accepted.
- 5. The rights of the parties shall be governed by, and the contractual terms shall be interpreted in accordance with the laws of the Province of Saskatchewan.
- 6. The City of Prince Albert is governed by The Cities Act and designated as a Local Authority pursuant to The Local Authority Freedom of Information and Protection of Privacy Act (LAFOIP). Therefore, all information collected during the Expression of Interest Process, including executed contracts and agreements may be subject to inspection through a Freedom of Information and Access Request in accordance with those regulations.

Section 91(1)(a) of the Cities Act states the following:

- **"91(1)** Any person is entitled at any time during regular business hours to inspect and obtain copies of:
  - (a) Any contract approved by the council, any bylaw or resolution and any account paid by the council relating to the City"
