## - APPLICATION FORM -

Homeowners, business owners and private owned facilities can apply to the City of Prince Albert under the Anti-Graffiti Program to receive assistance with graffiti removal located on exterior surfaces of their private property.

**NOTE:** *Painting and/or graffiti removal under the Program can only be undertaken on your own personal property. Residents are not permitted to remove graffiti on a neighboring property, public bench, community facility, utility company amenities, etc. Proof of address may be required, i.e. a tax notice, when applying for the program. If you are a renter of a property, then the owner of the property must be the one to apply for the program. The Anti-Graffiti Program does not cover costs that haven't been pre-approved by the application process, and any costs above and beyond the services offered on the application will be the responsibility of the applicant. The Anti-Graffiti Program is not retroactive.*
